This agreement is by and between Willow Lodge Pet Resort, LLC (h	ereinafter called "Willow Lodge")

service for the stay of Owner's pet and Willow Lodge:	
1. DISCLOSURE: By signing this Agreement and leaving Pet with Willow Lodge,	, owner certifies to the accurate
disclosure of all information provided to Willow Lodge either in writing or orally ab	oout the Pet and Owner
specifically represents that he or she is the sole owner of the Pet, free and clear of	all leins and encumbrances.
Owner agrees to disclose to Willow Lodge all known medical conditions and/or be	havior problems, which may
affect Pet's care. Owner specifically represents to Willow Lodge that Pet is healthy	and meets Willow Lodge's
published vaccination standards. Owner represents that each time Pet is brought	to Willow Lodge, Owner is
recertifying that Pet is in good health and has not had any communicable illness of	any kind for 30 days prior to
visit. Owner further agrees to inform Willow Lodge of any changes in Pet's conditi	on and/or behavior prior to
subsequent visits. Willow Lodge reserves the right to refuse service to any Pet for	any reason, at any time,
including, but not limited to: pets lacking proof of vaccinations, pets displaying sign	ns of untreated or potentially
contagious conditions and/or pets exhibiting aggressive or unacceptable behavior.	For the purposes of this
Agreement, the terms "Pet" or "Pets" refer to all pets under said ownership of Ow	ner who utilize services at
Willow Lodge, either now or in the future.

2. PAYMENT: Owner agrees to pay the applicable service rates in effect on the	
Lodge and to pay for any additional services requested by Owner. Payment for all	
reserved will be paid for at time of check-out, including all additional or ancillary so	ervices.

3. ASSUMPTION OF RISK: Willow Lodge agrees to exercise reasonable care	of Pet during its stay and, if
applicable, during transport. Owner is aware that employees of Willow Lodge are	not veterinarians and do not
have backgrounds in animal medicine and are not expected to diagnose or detect	illnesses in the pets at Willow
Lodge. Owner acknowledges that no amount of vaccination requirement, sanitation	on or personalized care can
prevent pets from contracting an airborne virus or communicable disease. Owner	further understands that pets
are pack animals, lead with their teeth, paws/claws, are unpredictable in nature ar	nd no amount of supervision
can be 100% certain to prevent pets from being injured. Owner understands these	e risks of illness, disease or harm
and hereby releases Willow Lodge, it's employees, members or other agents, from	any and all losses, damages,
costs and expenses arising out of or in connection with any communicable disease	, airborne virus, or any other
medical condition or injury contracted by Owner's Pet at Willow Lodge. Furthermo	ore, if Pet is transported to or
from Willow Lodge by Willow Lodge staff, Owner holds Willow Lodge harmless in t	the event of injury or accident

Owner also understands that squirt bottles, and in extreme cases, muzzles may be used for the protection

of other pets or staff. Owner further agrees to indemnify Willow Lodge a	and its agents against any claims made
against Willow Lodge or its employees or members or other agents or lo	sses or damages of any kind suffered by
Willow Lodge or its agents as a result of Owner's failure to inform Willow	v Lodge of any pre-existing condition Pet
may have (such as illness or aggression problems) or which were otherw	ise caused by Pet.

etc.), Owner authorizes Willow Lodge to obtain medical attention for Pet	t from a local veterinary clinic. In
such event, Owner grants to Willow Lodge and said veterinary clinic the	full power of decision-making
involving the medical treatment of Pet (including transport and care to a	nd from any agent) and agrees to pay for all
costs associated with said treatment. Owner agrees to hold said vetering	ary clinic, its employees and agents,
harmless from any and all claims as a result of treatment provided to Pet	t. Every attempt will be made to notify
owner and transport to your preferred veterinarian prior to obtaining me	edical care.

7. MULTIPLE FAMILY MEMBERS: If Owner requests to board Pet	t together with other "family members" in the
same suite, Owner acknowledges and understands that (regardless of the	e amount of supervision) such an
arrangement may decrease Willow Lodge's ability to detect issues, disease	ses and illnesses. Furthermore, because
actions of pets may be unpredictable, this arrangement may also signific	antly increase the chance of injury,
aggression and/or altercations. In the event of injury, aggression and/or	altercation between "family members",
Willow Lodge, in its sole discretion, may separate said "family members"	and Owner agrees to pay for all costs
associated with increased lodging.
